## **NOTICE OF INTENT TO PROVIDE HOME INSTRUCTION**

I am providing Notice of my intention to provide home instruction for the children listed below as provided by § 22.1-254.1 of the *Code of Virginia*, in lieu of having them attend school for the school year 20\_\_\_\_\_ - 20\_\_\_\_\_.

## Section I—Eligibility to Provide Home Instruction

I wish to be recognized as eligible to provide home instruction by selecting the option indicated below. (Check one below.)

- 1. I have a high school diploma or a higher credential. (Attach a copy of the documentation that shows this.)
- **2.** I have the qualifications prescribed by the Board of Education for a teacher. (Attach a copy of a teaching license or a statement to this effect from the Virginia Department of Education.)
- 3. I have provided the child with a program of study or curriculum which is to be delivered through a correspondence course or, a distance learning program, or in some other manner. (Attach a notice of acceptance or other evidence of enrollment showing the name and address of the school and a list of subjects to be studied for the coming school year if the child is enrolled in a correspondence course or distance learning program. If you choose to provide a program of study or curriculum in some other manner as specified in the *Code*, a list of the subjects to be studied for the coming school year must be submitted to the school division.)
- 4. I do not have a high school diploma or higher credential; I have attached to this Notice a statement which describes why I am able to provide an adequate education for my child(ren).

## Section II—Reminders and Dates to Remember

- I understand that by <u>August 1</u>, after this school year, I must provide evidence of progress for each child listed. Please attach evidence of progress to your annual renewal Intent Form. If I begin home instruction after the school year has started, I will submit this Notice as soon as practicable and comply with the other requirements within 30 days of this Notice to the school division.
- I understand that if the evidence is not provided by me, or if my child(ren) does/do not achieve an adequate level of educational growth and progress, my child(ren)'s program may be placed on probation for one year. *If the plan and evidence are not accepted, or the required evidence is not provided by* <u>August 1</u> *following the probationary year, home instruction shall cease, and the parent must make other arrangements that comply with the compulsory attendance law. (§ 22.1-254.1.C of the Code of Virginia)*
- I must <u>annually</u> notify the Division Superintendent by <u>August 15</u> if I wish to continue home instruction. This is accomplished by completing the Intent form for the new year and returning it to the Office of Student Leadership.

I understand that by August 1, following this school year, I must provide evidence of educational achievement as prescribed in (§ <u>22.1-254.1.C</u> of the Code of Virginia, which defines the requirements for home instruction.
