SUBJECT: Sole Source Purchase: Blue Box Air LLC HVAC Coil Cleaning Service

DATE: November 15, 2019

The sole source request is to hire Blue Box Air LLC for HVAC coil cleaning services at buildings identified by Maintenance Services. Total cost for the annual coil cleaning service shall not exceed eighty thousand dollars (\$80,000.00).

Coil cleaning is a critical aspect of routine HVAC maintenance. It affects equipment efficiency, energy consumption, air quality, heat transfer, and occupant comfort to name a few. Traditional coil cleaning techniques are often hindered by the lack of adequate coil access and operational downtime, so many coils remain uncleaned.

While any mechanical contractor can clean coils, Blue Box is the only HVAC coil cleaning service that provides non-chemical, no HAZMAT, HVAC coil cleaning in the country. They do not outsource or subcontract services or equipment. All service is provided solely by Blue Box Air. Blue Box is the only company to complete the service while the equipment is running, thus eliminating downtime and affording access to coils with limited or no service clearance that would otherwise be unable to be cleaned. Additionally, VBCPS has confirmed that no mechanical services contractor (RFP 4860-1, 2, 3, 4, & 5) can offer similar services.

Blue Box Air LLC warrants that no other items or products are available for purchase that would serve the same purpose or function and there is only one price for the above-named product because of exclusive distribution and marketing rights. There are no agents or dealers authorized to represent this service.

VBCPS has engaged Blue Box Air LLC to perform two (2) demonstrations, both of which impressed VBCPS and their engineering partners Thompson Consulting Engineers. Please see attached technical notes from both demonstrations.
